Aims of Bridging call – 2021 application call

- The purpose of building a pipeline of project ideas for the upcoming programme is strengthening the starting position of the new programme.
- To explore in practice the different themes proposed in the new programme which could influence the programme or help design future calls.





Aims of Bridging call – 2021 application call

- Bridging projects are preparatory projects funded by the current programme, targeting main projects for the future NPA programme 2021 – 2027
- Bridging project applicants are expected to have a view on the NPA 2021-2027 future Policy and specific objectives within the scope of the current NPA 2014-2020 priority axes.






- Project idea <u>must</u> address one of the four Priority Axes 2014 – 2020.
- <u>Project duration</u>: 6 months
- An eligible Lead Partner, and minimum of 2 partners from different 2 programme partner countries in the NPA area, one of which is located in a European Union Member State.
- Completion of an eMS preparatory project application form, including a work plan in line with the expected
 EUROPEAN UNION listed results.









EUROPEAN UNION



- NPA Eligibility rules are found in the Programme Manual on the NPA web site.
- Project Budget: Recommended ERDF 60.000 EUR. Proportional budget using ERDF grant up to 100.000 EUR in well justified cases plus non-Member State budget, using the regular intervention rates of programme partner countries.
- The budget will be paid on a lump sum basis upon completion of and meeting the conditions for funding.





 The lump sum is granted in accordance with Regulation (EU) No 1303/2013, Article 67 (5) and shall be established based on a draft budget on a case-by-case basis and agreed ex ante by the managing authority. The public support (ERDF support + public co-financing) for partners funded via ERDF shall not exceed EUR 100 000.





 Note: Partners from Scotland and Northern Ireland should apply for ERDF co-financing.

Application procedure

- Call period 16th August 2021 8th October 2021.
- Applications to be submitted via the online monitoring system (eMS)
- Decisions on Bridging call projects will be made by the NPA Monitoring Committee with input from Regional Contact Points and Joint secretariat.
- The decisions process takes place on December 8th, 2021.

Guidance for applicants -Reporting

- One final report is due within three months of completion and to be received no later than **November 30th, 2022**.
- A final report should include evidence of the work undertaken such as cases studies, feasibility studies, stakeholders mapping and target group development.
- Based on Lump sum principle the grant is paid out if all Grant Offer Letter conditions have been met.
